

# **Privacy Notice**

How we respect privacy when we deal with personal information collected by our organisation

This Privacy Policy applies to information we, Camp Jojo, collect about individuals who interact with our organisation. It explains what personal information we collect and how we use it.

Personal data that we process

The following table explains the types of data we collect and the legal basis, under current data protection legislation, on which this data is processed.

Purpose	Data (key elements)	Basis
Enquiring about our organisation and its work	Name, email, message	Legitimate interests - it is necessary for us to read and store your message so that we can respond in the way that you would expect.
Subscribing to email updates about our work	Name, email	Consent - you have given your active consent.
Making a donation	Name, email, address, payment information	Legitimate interests - this information is necessary for us to fulfil your intention of donating money and your expectation of receiving a confirmation message, as well as our duty to check that sources of donations are legitimate and consistent with our donations policy.
Signing up as a volunteer	Name, email, address, consent for DBS check, your completed application forms	Legitimate interests - this information is necessary for us to fulfil your intention of volunteering with us.
Signing up as a camper	Name, email, address, Your completed	Legitimate interests - It is necessary for us to store a small

	application forms	amount of information which enables us to cater for your needs during a camp.
Membership of Board	Name, email, address, declaration of interests Consent for DBS check, disclosure of interests	Legitimate interests - this information is necessary for us to fulfil your intention of serving as a Trustee or Adviser.
Contractor to provide services	Name, email, address, consent for DBS check,	Legitimate interests - this information is necessary for us to fulfil your intention of serving as an employee.

### 1. How we use your data

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy.

For example, we may use your personal information to:

- reply to enquiries you send to us.
- handle donations or other transactions that you initiate.
- where you have specifically agreed to this, send you marketing communications by email relating to our work which we think may be of interest to you.
- Use your information to facilitate camps in which you take part
- Using photographic and video of you in publicity material, but only with your explicit consent

## 2. When we share your data

We will only pass your data to third parties in the following circumstances:

- you have provided your explicit consent for us to pass data to a named third party.
- we are using a third party purely for the purposes of processing data on our behalf and we have in place a data processing agreement with that third party that fulfils our legal obligations in relation to the use of third-party data processors; or
- we are required by law to share your data.

In addition, we will only pass data to third parties outside of the UK where appropriate safeguards are in place as defined by Article 46 of the General Data Protection Regulation.

#### 3. How long we keep your data

We take the principles of data minimisation and removal seriously and have internal policies in place to ensure that we only ever ask for the minimum amount of data for the associated purpose and delete that data promptly once it is no longer required.

Where data is collected based on consent, we will seek renewal of consent at least every three years.

#### 4. Rights you have over your data

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time, and we will make it as easy as possible for you to do this (for example by putting 'unsubscribe' links at the bottom of all our marketing emails).
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Information Commissioner if you feel your rights have been infringed.

If you would like to access the rights listed above, or any other legal rights you have over your data under current legislation, please get in touch with us.

Please note that relying on some of these rights, such as the right to delete

your data, will make it impossible for us to continue to deliver some services to you. However, where possible we will always try to allow maximum access to your rights while continuing to deliver as many services to you as possible.

#### 7. Modifications

We may modify this Privacy Policy from time to time and will publish the most current version on our website. If a modification meaningfully reduces your rights, we'll notify people whose personal data we hold and is affected.
